We can help with all types of UK Visas

There are many different types of Visas, and each Visa requires different information. Take a look below at a brief description of each Family and Partner Visa. But if you are not sure what Visa you need, call us on 0115 845 6583.

If you would like to come to the UK as a Family member, a Spouse, or if you want to get married - there is lots of information that you need to provide. We make it as simple as possible by clearly telling you what we need.

The Home Office fees for applications do change each year (around April) and once you submit an application, they will not offer a refund. To avoid any unwanted costs, we advise that you come and see us first.

For most applications you need to show that you earn over £18,600 or have relevant savings in your bank account for a period of 6 months.

Standard Visitor Visa:

You can apply for a Standard Visitor visa if you want to visit the UK: for leisure, example; on holiday or to see your family and friends for business, or to take part in sports or creative events for another reason, example; to receive private medical treatment.

Marriage Visitor Visa:

You must apply for a Marriage Visitor visa if you want to get married or register a civil partnership in the UK, you want to give notice of a marriage or civil partnership in UK or you're not planning to stay or settle in the UK after your marriage or civil partnership.

Short Term Study Visa:

You can apply for a Short-term study visa if you're doing a short course of study in the UK.

↑ these Visitor Visa Routes are only for a period of <u>6 months</u>.

Spouse Visa:

If you wish to call your spouse to the UK you will need to meet the financial requirement of £18,600*, be legally married and have enough money to support yourselves.

*subject to change

Fiancé Visa:

If you (UK citizen) want to marry your partner (who is not in the UK), you must have evidence that you have met each other and intend to live with each other after you have been legally married, and also meet the financial requirement.

Apply to join family living permanently in the UK:

You must prove that you and your partner is 18 or over and in a genuine relationship. You must be one of the following: married or civil partners living together in a relationship for 2 years, engaged to be married or to become civil partners.

Apply to remain in the UK with family:

Your family member or partner can: be a British citizen that has settled in the UK or be your partner who has asylum or humanitarian protection in the UK. You may also be able to apply to remain with your child if they have lived in the UK for at least 7 years.

Apply to settle in UK if partner dies:

You can apply to settle in the UK if your partner dies and you're either: in the UK as the partner of a 'settled person', example; they had 'indefinite leave to remain' and you're their dependant in the UK as the partner of a British citizen, example; you married a British Citizen and have a UK visa on that basis.

↑ some of these Visa Routes are within a <u>5 or 10 year period</u>.

Indefinite Leave to Remain:

There are many different application depending on your circumstances, we advise that you contact us if you want to apply for ILR or need assistance with your application.

ILR applications have deadlines and you could get deported if you have submitted your application in time. Learn more about Settlement here.
